HOEC on behalf of its joint venture partner's seeks an Expression of Interest under International Competitive Bidding ("ICB") process from suitable experienced Contractors (Indian and International) for various Well Services to support its drilling & completion and also development of Facilities in AAP-ON-94/1 Block, Assam.

Only Contractors who have a minimum of five years' experience in providing the below mentioned Services, any or a combination of, in support of drilling campaign shall be considered.

Drilling & Completion Campaign

Program Duration

Well Re-Entry & Completion: 3 Wells

Drilling of new Well: 2 Firm + 5 Optional Wells

Drilling Depths: Ranging between 2,500 meters- 3500 meters approximately TVD (True Vertical Depth)

HOEC subject to approvals is also planning to drill additional new wells in addition to the above program.

The estimated duration of the campaign is approximately 7-8 months.

This program is expected to commence in Q42015/Q12016.

Development of Facilities

Operator intends to develop surface facilities for Dirok gas field development, which includes construction of gas processing plant with capacity to handle approximately 35 MMSCFD of gas and oil condensate of approximately 800 BOPD, gas collection station and laying of pipelines connecting wells to Gas collection station and then to Gas processing plant.
