SUMMARY OF PROCEEDINGS OF THE 35TH ANNUAL GENERAL MEETING OF HINDUSTAN OIL EXPLORATION COMPANY LIMITED

The 35th Annual General Meeting (AGM) of the Company was held on Monday, August 26, 2019 at 10:30 a.m. at “Tropicana Hall”, Vivanta Vadodara, Akota Gardens, Akota, Vadodara – 390020, Gujarat, India and concluded at 11:45 a.m.

Mr. Vivek Rae chaired the meeting and introduced the other Directors, Company Secretary and the Statutory and Secretarial Auditors present at the meeting. All the Directors, except Mr. Ashok Goel attended the meeting in person. The requisite quorum being present, the Chairman called the meeting to order. The Chairman then delivered his speech. The Notice of the meeting was taken as read with the consent of the members present.

The Chairman informed that the Company had provided the members the facility to cast their votes electronically on all the resolutions set out in the Notice. Members who were present at the meeting and had not cast their votes electronically were provided an opportunity to cast their votes at the end of the meeting by way of poll.

Members were informed that the Statutory Auditor’s Report and the Secretarial Audit Report for the financial year 2018-19 were unqualified. With that, the Auditor’s Report was taken as read with the consent of the members present.

The following items of business, as per Notice of 35th AGM were transacted at the meeting.

1. Adoption of the Audited Standalone and Consolidated Financial Statements of the Company for the financial year ended March 31, 2019 including Report of Board of Directors and Auditors.
2. Appointment of Mr. Ramasamy Jeevanandam (DIN: 07046442) as a Director liable to retire by rotation.
3. Appointment of Mr. Vivek Rae (DIN: 01866765) as an Independent Director
4. Payment of one-time additional Performance Bonus to the Executive Directors - Mr. Elango Pandarinathan, Managing Director and Mr. Ramasamy Jeevanandam, Executive Director & CFO
5. Re-classification of Burren Energy India Limited to public category
6. Ratification of remuneration to Cost Auditor for the financial year ending March 31, 2020

Clarifications were provided to the queries raised by the members.

Chairman then informed that Mr. S. Sandeep of M/s S. Sandeep & Associates, Practicing Company Secretaries, has been appointed as the Scrutinizer to the e-voting and poll at AGM process and authorized the Company Secretary to declare the voting results, intimate to the stock exchanges and place the same on the website of the Company.

The Chairman then thanked the members for their participation and announced formal closure of the proceedings of the 35th AGM of the Company.
