3. A demonstrable capability to mobilize and commence work to meet HOEC schedule. The Contractor's experience in mobilizing on schedule shall be clearly stated.
4. Details of HSE Organization, responsibilities, resources, standards and documentation, Risk management, Planning and procedures, Implementation and performance monitoring.
5. Details of HSE auditing and management review of HSE-MS, Valid Certifications / Accreditations
6. Details of established Quality Manual, Policy and Procedures, valid Quality Certifications, Accreditations.
7. Audited financial statements for the last three years.
8. Details of latest technology (if any) applied by the Contractor around company's operational area.
